An exciting program of activities is being planned this year for our children. Children's programming for children ages 3-10 (preschool – grade 5) will be available during both evening services and on the first day of Rosh Hashanah and Yom Kippur day until the afternoon break. For safety's sake, parents must check their children in and out with the attending staff member. Please Note: Staff will not be responsible for diaper changes. Please let all children know that they cannot play on the patio outside the service – their options are to stay in the activities room or go to services. Snacks will be provided, and if your child has special dietary needs, please provide it.

Morning Service/Program for 3 to 5 year olds (preschool – kindergarten in public school) in Gan Haverim:
Program begins at 9:00 am. An engaging service on the theme of the Holy Days will be held from 10-10:30 am, on both Rosh Hashanah and Yom Kippur day. Parents are invited to join their children for services! Snacks and activities are planned for the children until the end of the adult services.

Morning Service/Program for 6 to 10 year olds (grades 1 – 5 in public school) in the South classroom:
 Program begins at 9:00 am. An inspiring and participatory service for the Holy Days, led by Louis Sachs (Youth Group advisor) and some of our teens, will be held from 10-11:00 am on both Rosh Hashanah and Yom Kippur days in the South classroom. Parents are welcome to join their children for services if they wish! Snacks and a complete program of activities are planned for the children until the end of adult morning services.

Pre-Registration is MANDATORY so that we can plan adequately. WALK INS WILL NOT BE ACCEPTED. This registration form must be returned to the synagogue office by Tuesday, September 23rd. A \$10 fee per child/per program is due with registration. ***All are welcome regardless of ability to pay. Please let us know if we can help.***
